BIOGRAPHY

Adam Gusdorff's practice focuses on litigation involving trusts, estates, guardianships, and other fiduciary matters. Although Adam focuses his practice on litigation, he also has experience in estate planning, and he advises individual and corporate fiduciaries regarding estate and trust administration issues.

Adam frequently speaks and writes on matters concerning Orphans' Court practice, including general practice and procedure, the use of expert witnesses, evidentiary issues, prosecuting and defending claims against an estate, and the Dead Man's Rule. He is a member of the Pennsylvania, Philadelphia and Montgomery Bar Associations. He currently serves on the Executive Committee of the Philadelphia Bar Association Probate and Tax Section, and is a past chair and a current co-chair of the Section's Orphans' Court Litigation and Alternative Dispute Resolution Committee.
